



The South Carolina Police Accreditation Coalition (SC PAC) exists to improve the quality and delivery of law enforcement services to the citizens of its communities, by endorsing and assisting in the processes of national and state accreditation. SC PAC provides technical assistance to agencies in all phases of accreditation, from file setup and documentation,

to policy and procedure writing.

SC PAC provides thorough, preparatory “mock” assessment for both national and state accreditation. SC PAC membership also comprises of many assessors who conduct the actual assessments for the South Carolina Law Enforcement Accreditation program and CALEA (Commission on Accreditation for Law Enforcement Agencies, Inc.). SC PAC meets four times a year and hosts at least two training sessions including the training of assessors.

The South Carolina Law Enforcement Accreditation program is an initiative of the South Carolina Police Chiefs’ Association and the South Carolina Sheriffs’ Association. The Program is a voluntary program for professional improvement, fashioned in ways that best meet local needs while simultaneously expressing commitment to professional law enforcement practices. Agencies considering application for accredited status must be willing to provide emphasis and dedication not only to the initial accreditation process, but also to maintaining the process for the future.

The South Carolina Law Enforcement Accreditation program is managed and directed by the governing council of South Carolina Law Enforcement Accreditation (SCLEA). The SCLEA Program Administrator will serve as the point of contact for the South Carolina Law Enforcement Accreditation process.
